Conditions of Sale

GENERAL

All orders are accepted and goods supplied subject to the following express terms and conditions. No addition thereto or variation there from shall apply unless agreed in writing by the Parties.

ORDER CANCELLATION

If an order is cancelled by a Customer then the Customer shall indemnify LEGACY DISTRIBUTION LIMITED against all loss, costs (including the cost of all labour and materials used and overheads incurred, charges and expenses arising out of the order and the cancellation thereof LEGACY DISTRIBUTION LIMITED giving credit for the value of any such materials sold or utilised for other purposes).

In the event of any suspension of work through the customers instructions or lack of instructions the prices(s) quoted on the invoice may be increased to cover any extra expense thereby incurred by LEGACY DISTRIBUTION LIMITED.

DESPATCH DATES

Any times quoted for despatch are to be treated as estimates only. Whilst every endeavour will be made to meet these estimated times for despatch LEGACY DISTRIBUTION LIMITED shall not be liable in any manner whatsoever for failure to despatch within the time quoted.

CARRIAGE DELIVERY RISK AND TITLE

Unless otherwise agreed packing and carriage will be charged on the invoice for goods supplied. The risk of loss and/or damage to goods supplied by LEGACY DISTRIBUTION LIMITED shall pass to the Customer when they are delivered to the Customer or Company authorized by the Customer and LEGACY DISTRIBUTION LIMITED shall not be liable for the safety of the goods thereafter (and accordingly the Customer should insure the goods against such risks as may be commercially prudent.)

Any damage to goods in transit should be notified to the carrier and LEGACY DISTRIBUTION LIMITED within two days of receipt and the packing and contents held for inspection. If goods are not received by the customer within six days of invoice the carrier and LEGACY DISTRIBUTION should at once be informed.

The ownership of the goods shall remain with LEGACY DISTRIBUTION LIMITED (which reserves the right to dispose of them) until payment in full for all goods and materials has been received by LEGACY DISTRIBUTION LIMITED in accordance with the relevant terms.

PAYMENT

All accounts are strictly net and payable 30days from end of month..

If payment is overdue in whole or in part or immediately upon the commencement of any act or proceeding in which the Customers solvency is involved, LEGACY DISTRIBUTION LIMITED may (without prejudice to any of its other rights) recover or resell the goods or any part of them and its servants or agents may enter upon the Customers premises for that purpose.

WARRANTIES

In the case of defects or faulty workmanship in products or any parts thereof, the Customer shall not be entitled to receive any greater benefit than shall be received by LEGACY DISTRIBUTION LIMITED under any guarantee or warranty given to LEGACY DISTRIBUTION LIMITED by its manufacturing associates.

LEGACY DISTRIBUTION LIMITED shall not be responsible for non-performance in whole or in part of its obligations if such non-performance is due to acts of God, war, insurrection, Government regulations, embargoes, strikes, labour disputes, illness, flood, fire, tempest or any other cause beyond the control of LEGACY DISTRIBUTION LIMITED.

CONSEQUENTIAL LOSS AND DAMAGE

Save as herein expressly provided LEGACY DISTRIBUTION LIMITED shall not be liable for any loss or damage of whatsoever nature or to whomsoever caused arising out of the use of goods supplied by it.

JURISDICTION AND LAW

These Conditions and the contract to which this document relates shall in all respects be construed and operate in accordance with English law.

CANCELLATIONS AND RETURNS

Credit will not be issued on any goods returned without prior written authorisation.
